Table 2: Main features of capital instruments

The Credit Union regulatory instruments comprises of Retained Earnings, General Reserve for Credit Losses and Capital Redepmption Reserve. The Capital Redemption Reserve represents the amount of redeemable preference shares redeemed by the Credit Union since 1 July 1999. The Law requires that the redemption of the shares be made out of profits. Since the value of the shares has been paid to Members in accordance with the terms and conditions of the share issue, the account represents the amount of profits appropriated to the account.
